Dear Rick,

Thank you for your time on the telephone today, I appreciate your assistance. During our conversation you stated that residents of the State of California, regardless of domicile are subject to BOE sales and use tax, I do not disagree with your position on the issue of residents, however during our call the connection seemed to prevent our conversation from continuing. As a result of our bad telephone connection I thought it to be a best practice to put my question in writing.

The sales and use tax authorized to be collected by the CA BOE appears to be applicable to residents of California, U.S. Citizens conducting taxable transactions in CA STATE. I have acted to aquire domicile in California 1849, I am not a U.S. Citizen, I am however one of the People of California.

The mistaken belief of many business owners operating in California is that all inhabitants of California are subject to the use and sales tax administered by the BOE regardless of political status or domicile. To clear this misunderstanding I require that you respond to the following:

Is it the position of the CA BOE that sales and use tax is applicable to the People of California 1849 regardless of domicile?
